Next Stop: The World

Contest Rules and Eligibility

1. Eligibility

Contest open to legal residents, age 18 and older, of the United States, its territories and possessions. Employees, officers and directors, and members of their immediate families or of their households (whether related or not) of the Massachusetts Bay Transportation Authority ("MBTA"), its consultants, vendors or contractors and promotion partners are not eligible. Contest is void where prohibited by law. All applicable federal, state and local laws and regulations apply, as well as Twitter's Terms of Service.

2. Entry

Eligible persons may enter the Video Contest beginning February 14, 2020 and ending February 28, 2020, 11:59 pm Eastern Standard Time. No person may submit more than five videos. Eligible persons need to have a Twitter account and must post videos on Twitter at Hashtag #NextStopTheWorld to be eligible. Video must be 60 seconds or less, and include which bus route, subway, trolley, train, ferry, or station serves the neighborhood featured in video submission.

3. Prize

The Judges will select one winner. The winner will receive two roundtrip flights between Boston Logan and cities served by JetBlue. Approximate value for JetBlue Airways travel certificates is \$599. JetBlue is a participant in this promotion. The prize is non-transferable. Neither the MBTA, JetBlue Airways, their affiliates, subsidiaries, parents, partners, divisions or judging agents and each of their respective employees, officers or directors will be responsible for any loss, liability or damage arising out of any winner's acceptance or use of any prize. The Judges' decision is final in all respects. Winner will be notified by the MBTA by Direct Message on the Winner's Twitter account within 14 days of the closing date of the Contest. Winner may be required to execute a Statement of Eligibility and Release within 30 days of prize notification attempt or winner may be disqualified and prize may be awarded to an alternate winner. In the event any winner is 18 years of age, but still considered a minor in his or her place of residence, all required documentation must be signed by parent or legal guardian.

Return of prize or prize notification as undeliverable will result in disqualification and an alternate winner may be selected. Entry and/or acceptance of prize(s) constitutes permission for the MBTA to use any winner's name, address (city and state) and/or likeness for advertising and marketing purposes without further compensation or authorization, worldwide and in perpetuity, in any and all forms of media, now known and hereafter devised, unless prohibited by law.

5. Conditions

By entering, participants agree to be bound by these Contest Rules and agree that the MBTA may use any video or photography submitted in connection with this contest for any lawful purpose.

Videos must not include the following: 1) Racist, sexist, or other offensive remarks, 2) Nudity or sexual content, 3) Promotion of drug use, underage drinking, or other illegal behavior, 4) Violation of privacy laws of individuals or companies, 5) Any other offensive or inappropriate content as determined by the MBTA. Violation of these parameters will result in immediate disqualification. Participants are responsible for compliance with all applicable laws and agree to indemnify the MBTA, jetBlue Airways, Twitter, their affiliates, subsidiaries, parents, divisions and their officers, directors and employees, for any loss, cost or damages suffered by any indemnified party.

Videos may not use any copyrighted music or images, unless the producer owns the copyright or obtains a license. The MBTA obtains the right to ask for written proof of ownership or license.

Any person attempting to defraud or in any way tamper with this Contest will be ineligible for prizes and may be prosecuted to the full extent of the law. The MBTA reserves the right to terminate or modify the Contest at any time for any reason. In such circumstances, the prize will be awarded based on entries received to date of termination. Violation of any **provisions** of these Contest Rules is grounds for disqualification.

EXHIBIT A

JetBlue Flight Travel Certificates Terms and Conditions

Each Travel Certificate is good for one-time use by one person in accordance with the travel restrictions identified on or in connection with the Certificate.
