

# MBTA Youth Pass Application 2021-2022

Thank you for your interest in the Youth Pass Program, a partnership between the MBTA and participating cities/towns (or their nonprofit designees), to offer reduced fares to eligible young people.

Youth Pass CharlieCards can be loaded with cash value (for a roughly 50% reduced one-way fare) or \$30 monthly LinkPasses for unlimited travel on bus, subway, and Fairmount Line Zone 1A stations.

To be **eligible** for the Youth Pass Program, you must:

- Live in a participating city or town;
- Be between the ages of 12 17 on the date that you apply and NOT able to get a Student CharlieCard (M7 or S-Card) through your school, or
- Be between the ages of 18 25 on the date that you apply AND enrolled in at least one of the following Youth Pass partner programs:
  - State or federal benefit program (e.g., MASSGrant, MassHealth, SNAP)
  - Alternative education program (e.g., high school equivalency program)
  - Job training or professional development program (e.g., Year Up, Roca)

In order to complete this application, you must submit documents that show proof of age, address, and if you are 18 – 25, enrollment in a Youth Pass partner program. Submitting an application does not guarantee participation in the program.

# Terms of Use

Participants may not allow anyone else to use their Youth Pass CharlieCard. The MBTA may inspect Youth Pass CharlieCards at any time. Lost cards must immediately be reported to the city/town/nonprofit office from which you obtained your card.

An unauthorized person using a Youth Pass CharlieCard may be subject to criminal/civil penalties under Chapter 161, Section 113A of the MA General Laws and/or any other applicable MA General Laws. Additionally, Participants may be disqualified or suspended from participating in the Youth Pass Program for allowing unauthorized use of their cards.

## Collection, Use, and Deletion of Participant Information

The MBTA may use Participants' personally identifiable information to investigate possible fraud or misuse of the Youth Pass.
