# **GLT Improvements Continue Across the Green Line**

## • Symphony Station Accessibility Improvements

Utility relocation work continues in preparation for accessibility improvements at <a href="Symphony Station">Symphony Station</a>. This week, crews are backfilling the excavation for the steam line near Symphony Hall. Looking ahead, crews will work on the southern MBTA power duct bank once backfilling for the steam line is complete. More details can be found on the <a href="project website">project website</a>.

## **Adjacent Projects**

We also want you to be aware of adjacent projects. While the GLT team does not directly oversee these projects, we coordinate closely with the teams leading them. ### • Service Suspension

Shuttle buses replace Green Line service between North Station and Medford/Tufts from 8:45 PM to end of service, through **Sunday**, **December 10**, for track work. Union Square riders should use Bus routes 86, 91, or CT2 to connect to shuttles or the Orange Line. There will be no shuttle service to Union Square.

### • Haymarket Bypass

Green Line trains will bypass Haymarket Station in both directions through **Saturday**, **December 16** to allow for work on the Government Center Garage demolition.

### • Upcoming Shuttle Diversion

Shuttle buses replace Green Line service between Riverside and Kenmore starting **Monday, December 11**, through **Wednesday, December 20**, for track work. Shuttle buses will stop at all D Branch stations, except for Beaconsfield. More information about alternative travel options is available on the <u>Alerts page</u>. Please note the schedule for these major infrastructure projects is dependent on weather and subject to change without notice.
