



Today's presentation will provide background information on procuring contracted construction services for **Supplemental Track Improvement Program Contract 1-Green, Blue and Orange Line, Systemwide** through MBTA Contract No. T35CN01, which will consist of track rehabilitation to support the MBTA in addressing speed restrictions and state of good repair on the Green, Blue, and Orange Line, thereby increasing the MBTA's ability to provide a safe and reliable trip and improve the overall quality of service.











Improved Quality of Service

Planned Improvements

- Full-depth track replacement
- Rail and tie replacement
- Tamp, surface, and align tracks

Benefits

Construction of the Contract

- Construction Procurement proactively contacted track contractors (both inside and outside of Massachusetts) to understand their reluctance to bid on track On-Call contracts
- Contract is packaged to increase competition by:
 - Packaging defined scope by lines
 - Providing pre-planned continuous access over a period of time
- Pre-bid activities
 - Pre-bid bus tour of track access points
 - Schematics and videos of track available for review
- Included Incentive and Disincentive Language



Construction Procurement

- Project advertisement: February 21, 2024
- Bid opening: March 14, 2024
- DBE Goal: **5**%
- Two prequalified and eligible bidders:
 - Railroad-SPS New England, a Joint Venture \$16,120,388.00*
 - Skanska Delta, Joint Venture \$16,782,000.00

*A bid analysis was completed and Railroad-SPS New England, a Joint Venture is the selected lowest, eligible, and responsible qualified low bidder
