

The MBTA Climate Assessment:

- Sets a vision for climate and sustainability work at the MBTA.
- Defines resilience in the MBTA context: "activities to plan for, mitigate and adapt to risks from adverse climate impacts to minimize disruption and rapidly restore service where disrupted."



Coastal flooding, extreme precipitation and temperatures, and heavy winds are the primary climate hazards facing the MBTA.





### The MBTA has several major resilience initiatives underway.



#### **Resilience planning**

 Laying groundwork to develop a systemwide resilience roadmap leveraging vulnerability assessments and internal engagement

#### Systemwide tunnel flood mitigation program

- Released RFQ/RFP for Airport Tunnel Flood Portal
- Next steps for SGR pump room upgrades and SCADA integration

#### **Collaboration across the Healey-Driscoll Administration**

- Supporting the Office of the Climate Chief in assessing the economic cost of resilience
- Participating in ResilientMass Finance Initiative and efforts to set resilience metrics across state government

## Ongoing financial support from state (MassDOT, EEA) and federal (FEMA, EPA) partners, including:

- MassDOT allocation of PROTECT formula funds
- FEMA Building Resilience In Communities (BRIC) application for Airport Tunnel Portal
- Engagement in Army Corps coastal risk studies
