Safety Performance Indicator Reporting

- Each month, the Board of Directors will receive a report on safety metrics and performance summaries of the various modes.
- Safety Performance Targets come from the Transit Safety Plan and the Railroad System Safety Program Plan.
- Events related to Performance Targets are tracked in MBTA Safety databases from OCC and third-party reporting.
- Key Safety Performance Indicators including benchmarks and mitigations will be presented at each SHE meeting.

Collisions with Object	0.19	0.00
Collisions with Person	0.65	0.00
Collisions with T Vehicle	0.00	0.00
Total Reportable Smoke/Fire Incidents	3.21	0

- 33% of injuries occurred while alighting trains
- 33% of injuries occurred on stairs or an escalator

Total Reportable Smoke/Fire Incidents	5.88	4.00

- One collision involving two hi-rail vehicles on track
- Below target on all other indicator rates

Collisions	2.86	3.91
Collisions with Vehicle	1.36	0.00
Collisions with Object	0.44	0.00
Collisions with Person	0.48	1.95
Collisions with T Vehicle	0.58	1.95
Total Reportable Smoke/Fire Incidents	3.95	0.00

• 7 injuries reported from Red Bridge derailment on 10/1/24

 Absent the Red Bridge derailment, the injury rate would be 1.75

#### Safety Performance Indicators – Bus October 2024

Performance Indicator Rate	Bus Target	Bus Actual
Customer Injuries	2.55	2.15
Collisions	60.08	91.28
Collisions with Vehicle	46.23	72.91
Collisions with Object	10.18	12.24
Collisions with Person	1.58	2.78
Collisions with T Vehicle	2.09	3.34
Total Reportable Smoke/Fire Incidents	1.28	1.00

- 105 total collisions of which 65 were determined to be non-preventable
- All minor no collisions with disabling damage to the bus
- By comparison, there were 168 bus collisions reported in October 2023
- Target rates set from incident data during the period of 2020-2022

### MBTA 2024 Transit Safety Plan Approval

- MBTA 2024 Transit Safety Plan was approved by DPU on January 14, 2025.
- This was most recently approved by the Board of Directors at the December 2024 meeting.
- MBTA Safety Management Systems Department is beginning to work with relevant stakeholders on updates for the 2025 Transit Safety Plan, which will be due to DPU in September.
