Paratransit Service

- Essential and ADA-mandated mode of transit that serves as an alternative to bus and subway service for people who cannot use fixed route due to a disability.
- Unlimited door-to-door shared ride service is provided to eligible customers 365 days a year anywhere in The RIDE's service area for three years.
- Service area is ¾ mile from MBTA fixed route bus or subway

Trips booked via reservation 1 – 5 days in advance. Confirmations sent via phone and text

The RIDE exceeds ADA requirements in many ways, including the size of the service area, door to door service, fares and the popular optional supplemental service called The RIDE Flex







- MBTA partnership with Uber and Lyft to offer expanded mobility options through limited MBTA subsidized trips
- Offers optional supplement for RIDE customers to take same day Non-ADA trips with Flex
- Customers can book subsidized trips directly with Uber and Lyft and TRAC can shift trips to non-dedicated providers as needed
- Trips shifted from DSPs to Uber/Lyft continue to decline as our service providers hire drivers




