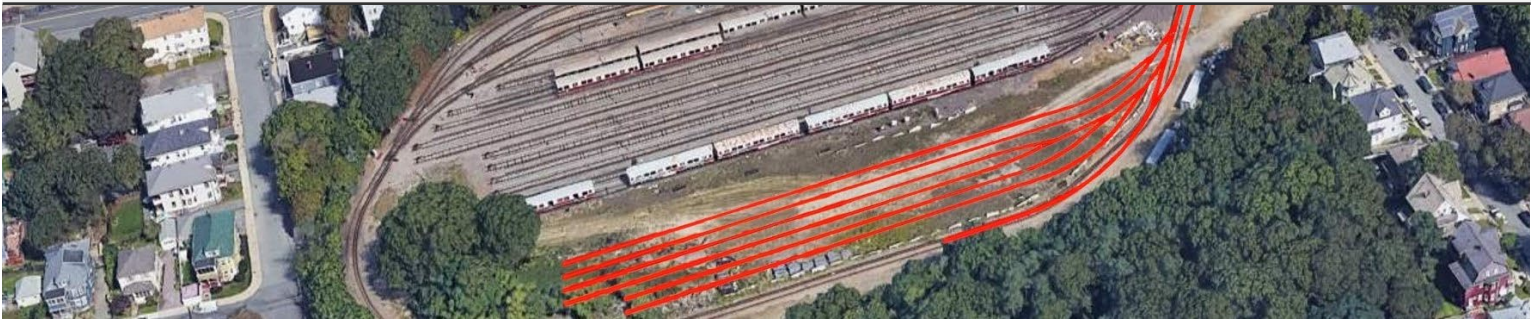
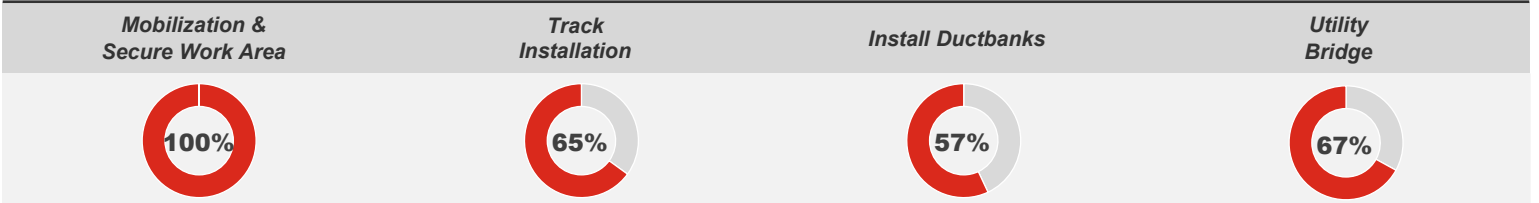


# Codman Yard Construction Update | March 1 to March 21, 2025
