The Contractor further certifies that upon the payment of the amount listed in paragraph 3 hereof, and of any amount which may be deducted from paragraph 2 hereof, he will release the Massachusetts Bay Transportation Authority from any and all claims of any nature whatsoever arising out of said contract or modification thereof, and will execute such further releases or assurances as the Massachusetts Bay Transportation Authority may request.
