

- Finance Plan submitted to FTA on June 5, 2017
- Application for Federal CMAQ funds submitted May 31, 2017
- Anticipate access to Federal CMAQ funds July 1, 2017
- Federal FY17 budget, which included \$150M for GLX was signed into law on May 5, 2017
 - To date, \$400M of FTA's \$996M has been appropriated (source of funds is 2015 Full Funding Grant Agreement)
